# **General information**

#### Who should complete this form?

Use this form to calculate and claim your new housing rebate if you bought a new house (including a residential condominium unit or a duplex) or a share of the capital stock of a co-operative housing corporation (co-op). The house must be the primary place of residence for you or a relation. If more than one individual owns the house or share, only one individual can claim the rebate. Partnerships (even if all the partners are individuals) and corporations that buy new houses are not entitled to claim this rebate. An individual cannot claim this rebate if a partnership or a corporation is also an owner of the house.

Do **not** use this form if you built or substantially renovated your house or hired someone to do so. Instead, use Form GST191, *GST/HST New Housing Rebate Application for Owner-Built Houses.* 

For information on the conditions that apply for each rebate type, see Guide RC4028, *GST/HST New Housing Rebate.* 

If the application is signed by someone other than the claimant, you must attach a properly executed power of attorney to this form.

If your house is located in a province that offers a provincial new housing rebate for some of the provincial part of the HST and you qualify for that rebate, you also need to complete the appropriate provincial rebate schedule to claim the provincial new housing rebate.

#### **Documentation required**

If you send the application directly to us, you have to send the following documents with it:

- a copy of the statement of adjustments;
- proof of occupancy (such as a copy of the new house insurance policy with dates and coverage; your vehicle insurance or registration that shows the new address; or an invoice for telephone, hydro, or natural gas hookup); and
- for a mobile home, a copy of the invoice.

Do **not** send us the agreements for the purchase of your house. Keep them for six years in case we ask to see them.

### When should I file my claim?

Generally, you have two years from the date ownership of the house is transferred to you to claim the rebate.

## Where do I send this form?

**If you are a builder** who has filed your GST/HST return electronically, has paid or credited the GST/HST new housing rebate, and you are claiming the amount of the rebate as a deduction on line 135 of your GST/HST return, enter in Section D of this form the reporting period in which you claimed the deduction. Mail this form and any applicable provincial rebate schedule to the Summerside Tax Centre at the address below.

If you are a builder who is eligible to file a paper GST/HST return and you are claiming a deduction on your paper return for a GST/HST new housing rebate amount you paid or credited, enter the reporting period in which you claimed the deduction in Section D of this form. Send this form and any applicable provincial rebate schedule along with your return in which you claimed a deduction to the tax centre indicated on your return.

If you are claiming a Type 2, 3, or 5 rebate, mail this completed form and any applicable provincial rebate schedule along with the supporting documentation to:

The processing of your claim may be delayed or your rebate denied if this form is not completed in full, the rebate calculation is not correct, or the documentation requested is not submitted with your application. You can only apply for the rebate once for each house, using one application form.

#### Definition

**House** – for this rebate, includes a single family home, a residential condominium unit, a duplex, a mobile home, and a floating home. It also includes a bed and breakfast if more than 50% of the house is your primary place of residence. Otherwise, only the part that is your primary place of residence is a house for purposes of this rebate.
